Summary of Responsibilities

The Gateway Development Commission is seeking a highly qualified Special Advisor, Tunnel Construction (Part-Time) to provide critical support to the Chief Technical Officer (CTO). In this role, you will leverage your expertise to assist the CTO in strategic decision-making, project management, and technical oversight. Your contributions will play a vital role in advancing the mission of the Gateway Development Commission to enhance transportation infrastructure in the New York and New Jersey metropolitan region.

Essential Functions

- Collaborate closely with the CTO to provide expert guidance and support in technical matters related to infrastructure development and improvement projects.
- Conduct in-depth research, analysis, and evaluation of technical aspects, industry trends, and best practices to inform decision-making processes.
- Assist in the formulation and implementation of strategies to ensure the successful execution of infrastructure projects, adhering to quality standards, budget constraints, and regulatory requirements.
- Provide technical oversight and review of project designs, plans, and specifications, offering recommendations and solutions to optimize project outcomes.
- Coordinate with cross-functional teams, including engineers, architects, contractors, and project managers, to ensure seamless project execution and effective communication of technical requirements.
- Support the CTO in evaluating and selecting contractors, consultants, and vendors, ensuring technical competence and compliance with project goals.

- Demonstrated ability to work in a fast-paced, dynamic environment and manage multiple priorities with attention to detail.

### Project Background

The Gateway Program is the most urgent infrastructure program in the country – a comprehensive set of rail investments that will improve commuter and intercity services, add needed resiliency and, in its later stages, create new capacity between Newark, New Jersey and New York City, the busiest section of the Northeast Corridor (NEC). The NEC between Boston, Massachusetts and Washington, D.C. is the nation’s busiest rail corridor, supporting a region that produces 20% of the Gross National Product. The 10-mile segment of the NEC within the scope of the Gateway Program carries over 200,000 daily Amtrak and NJ TRANSIT passenger trips on approximately 450 trains during non-pandemic conditions and is a vital artery in the region.

The first phase of the Gateway Program includes the Hudson Tunnel Project, which includes the construction of a new two-track tunnel under the Hudson River connecting to Penn Station New York as well as the full rehabilitation of the existing 110 year-old North River Tunnel. The project would create operational flexibility, rail network redundancy, and resiliency against future impacts to the Hudson River rail crossing. Environmental review for the project was completed in May 2021.

The Gateway Development Commission, established through bi-state legislation, is responsible for the financing and development of the Hudson Tunnel Project. The Commission is governed by a Board of 7 Commissioners appointed by each of Amtrak, New Jersey, and the New York State Department of Transportation, and works in partnership with Amtrak, NJ TRANSIT and the Port Authority of New York and New Jersey.
