The new approach was developed utilizing feedback from the private sector as well as partnering with the Federal Transit Administration to advance the Captial Investment Grant process GDC is undergoing. REBNY commends GDC for working so closely with the private sector to elicit feedback from industry experts and ensure a competitive and qualified group of bidders for the project, which will keep the project moving forward and towards completion in a timelier manner.

The Gateway Project is critical to the region's economic growth and recovery. HTP will create over 72,000 jobs for the region and will provide long-term climate resiliency. Good afternoon-

I am here today to voice Tri-State Transportation Campaign's on-going and strong support for moving the Gateway Project forward.

Time is of the essence in moving this national priority infrastructure project closer to achieving a full funding grant agreement with the Federal Transit Agency. We hope there is a determination as quickly as possible to move the Hudson Tunnels Project to Phase 3, the engineering phase. Toward that end, now that there is a completed memorandum of understanding between New Jersey and New York, we encourage you to pass the resolutions brought forward today. This project is not possible without a strong partnership and cooperation between the private and public sectors.We support the sensible, revised procurement strategy to build the HTP by splitting the civil works into smaller packages. Splitting these projects up allows them to move forward more quickly and efficiently.

In this era of high inflation, supply chain issues, and intense competition for engineers and construction it makes sense to chunk up the work as we continue to move the project forward at the federal level. The indications from DC–the MEGA grant for the Hudson Yards concrete casing project and the good news that President Biden included an allocation of \$700 million in CIG funds in his FY24 budget–are positive. Let's move ahead on completing the concrete casing project as quickly as possible.
