Initially, Respondent included form T-5 from the Specialty Subcontractors. Now that there is no Specialty Subcontractor, our subcontractor is merely a Principal	A Form T-5 (Table 2) is only required for the Respondent and each entity comprising the Contractor, as clarified in Addendum 2.

3	Addendum 3; §5.2	Since GDC removed §5.2, is it the intent that all subcontractors must be dedicated subcontractors to the respondent team?	In accordance with Section 5.3, none of the Principal Participants, their respective Affiliates or any Key Personnel on a Respondent team may participate in any capacity on another Respondent team during this procurement. If a subcontractor is not a Principal Participants, their respective Affiliates or any Key Personnel on a Respondent team, they do not need to be dedicated to the Respondent team.
4	Addendum 3; §4.1.1	We submitted several updates to our Expression of Interest. In our latest submission dated July 5, 2023, Respondent had included organizational information for Contractor/Design-Builder, Designer, and Dedicated (Specialty) Subcontractor. We did not include our Principal Participants. With the elimination of Specialty Subcontractor, should we update our Expression of Interest to include our Principal Participants in our organizational structure?	No, updates to the Expression of Interest are not needed as long as one has already been submitted from Respondent or one of the Principal Participants. Details about the Respondent organizational structure are not necessary for Expression of Interest purposes.
	Addendum 3; §4.1.1; §8.3 (c)	Will Gateway Development Commission acknowledge our latest Expression of Interest so that we know we are permitted to submit an SOQ under our current organizational structure? Our initial Expression of Interest had a different point of contact than our latest Expression of Interest. Will Gateway Development Commission remit instructions for submittal to our latest point of contact?	Updates to the Expression of Interest are not needed as long as an Expression of Interest has already been submitted from Respondent or one of the Principal Participants. Details about the Respondent organizational structure are not necessary for Expression of Interest purposes. GDC will use contact information provided in Expressions of Interest for direct circulation of Addenda.
