TO PROSPECTIVE RESPONDENTS **GDC23-004** –Palisades Tunnel Request for Qualification (“RFQ”)

Below are questions and/or requests for clarification received from potential proposers and GDC’s responses. The questions are restated for convenience only, may have been edited for clarity and are not part of GDC’s responses. GDC’s responses do not modify the provisions of the RFQ (except where indicated). GDC’s responses are intended only to identify relevant Contract provisions and clarify any perceived ambiguities.

The following changes are hereby made in the Request for Qualifications for the subject Contract.

1.	Appendix 2	We request that the "Deadline for Registration of Submittals by the Respondents" be extended to be due the same day as the SOQ Submission.	Yes, the deadline for the Registration Submittals in the RFQ is extended to the same day as the SOQ Submissions.
2.	Info Session	Will the owner utilize or require "Digital Construction Management" as being funded and driven via IJJA/BIL? OR do you already have initiatives in place for "digital construction management" tools?	Digital Construction Management is not a specific requirement at this time.
3.	Info Session	Is there a stipend for phase 2?	No, a stipend will not be provided as part of the Palisades RFP process.
4.	Info Session	Will a SCADA package be required for temporary utilities such as power and ventilation?	SCADA will be defined in the requirements for future contracts.
5.	Info Session	Has an Engineer's Estimate been published?	No, an Engineer's Estimate has not been published.
6.	Info Session	What is the minimum required design experience for the designer?	Please see Appendix 9, Section 3 of the RFQ for details about the minimum required experience for each Key Personnel.
7.	Info Session	Will TBMs be excluded from Buy America requirements?	Buy America will be determined based on FTA requirements.
8.	Info Session	Are there opportunities for technology companies in modeling, data management and data science?	Such companies would be utilized by the Contractor based on their needs, means and methods.
